**BUSINESS ITEMS:**

**Depository and Monthly/Annual Meetings.** Retain Century Bank & Trust, Quincy MI. as Depository and retain monthly Twp. Board meeting schedule as 7 P.M. the 4<sup>th</sup> Monday of each month except 1 week prior if 4<sup>th</sup> Monday falls on a holiday, Annual Meeting to be held before the regular March monthly meeting (meetings to be held at the Butler Twp. Hall).

**SALARIES/ETC:** (and effective date, if changed)

**Supervisor:** \$6000 (Annually)

**Assessor:** Contract dated April 1, 2019 through Mar. 31, 2020-\$12 per tax parcel (872 parcels) for a total of \$10,464; payable in monthly installments of \$872.00.

**Treasurer:** \$6400 (Annually) **Clerk:** \$6400 (Annually) **Deputy Treasurer:** \$150 (Annually) **Deputy Clerk:** \$150 (Annually).

**Trustee:** \$70 per meeting or Township related meeting. **Board-of-Review:** \$70 per day, \$12 per hr. over or less than a 6 hr. day. **Election workers:** Chair \$10 per hour. Inspectors \$9 per hour, including School Elections.

**Sexton:** \$6500 (Annually) with payments April through September. Labor beyond contract @ \$16 per hour tractor/machine labor, \$10 per hour manual labor. The grave openings and closings will be: Cremation \$100. Full burial Child \$200- Adult \$300. All burials \$50 upcharge for weekend service. Additional \$50 upcharge for Winter burials, Dec. 1 through Mar. 31<sup>st</sup>, due to extra equipment and costs. Cemetery gravesite cost \$250. **Other Compensations:** **Zoning Administrator:** \$3500 (Annually) 4/1/19 through 3/31/20 + mileage @ \$0.58 per mile. **Planning Commission members:** \$15 per meeting. Chairperson \$20 per meeting. **ZBA members** \$15 per meeting. **Mileage:** \$0.58 per mile. **Motion to approve Business Items, Salaries/etc. and Other Compensations as presented by Brenner/Hammontree.** All-in-favor.
